- Developed own 'language' jargon, exclusive;
- 'All degree' profession;
- The deal was sealed exclusive, 'professional'

#### **Community Development**

Three core requirements/ ingredients:

- 1. Everyone has something to offer and those affected by an issue need to be integral in identifying solutions;
- Partnership no one person/ organisation can do it all (reality not rhetoric);
- 3. Equalities challenges e.g. racism, sexism, homophobia...

#### 10 Qualities of a Professional:

#### 1. Appearance:

A professional is neat in appearance. Be sure to meet or even exceed the requirements of your company's dress code, and pay special attention to your appearance when meeting with prospects or clients.

#### 2. Demeanour;

- 3. Reliability;
- 4. Competence;
- 5. Ethics;

- 6. Maintaining Your Poise;
- 7. Phone Etiquette;
- 8. Written Correspondence;
- 9. Organizational Skills

#### **10.** Accountability:

Professionals are accountable for their actions at all times. If you make a mistake, own up to it and try to fix it if possible. Don't try to place the blame on a colleague. If your company made the mistake, take responsibility and work to resolve the issue.

### **Professionalisation:**

*"a social process by which any trade or occupation transforms itself into a true 'profession of the highest integrity and competence.'"* 

#### **Results in:**

- Establishment of acceptable qualifications;
- Professional associations recommending best practice and overseeing conduct of members of the profession;
- Separation of the qualified from unqualified (professional certification);
- Likely to create "occupational closure", closing the profession to entry from outsiders, amateurs and the unqualified.

- Community People commitment, ability, knew local issues;
